I. Gift certificate overview

By issuing gift certificates with a premium (20% premium rate) that can be used at stores in Fukuoka City, we aim to reduce the burden of purchasing products and services, increase new consumption, and increase local consumption. The purpose is to contribute to expansion and revitalization of the local economy.

- 1. Name FUKUOKA NEXT Pay (Abbreviation: Nexpei)
- 2. Fukuoka Chamber of Commerce and Industry, Sawara Chamber of Commerce and Industry, Shiga Chamber of Commerce and Industry Part of the shopping district in Fukuoka city (details are on the official website)
- 3. Total issue amount 6 billion yen (including premium portion) *Premium rate 20%
- 4. Issuing format Electronic gift certificate (system using the QR code function of smartphones)
- 5. Sales price 5,000 yen to 50,000 yen (sold in units of 5,000 yen)
- 6. Period of use June 19, 2023 (Mon) to December 18, 2023 (Mon)
- 7. Sales method Reservation lottery sales (advance winning until sold out)
- 8. Purchase limit 50,000 yen per person (face value 60,000 yen)
- 9. Number of registered stores Approximately 7,000 stores (planned), including retail stores, restaurants, and inns in Fukuoka City
- 10. No conversion fee
- 11. Transfer fee Free (paid by the issuer.)

II. Strict observance of gift certificate handling

- Odift certificates can be used in transactions such as the sale of goods or the provision of services.
- OExchange of gift certificates for cash is prohibited.
- OPlease receive the shortfall in cash.
- OCash refunds are not possible when returning merchandise. Also, if an erroneous payment occurs, please cancel it.
 - Please confirm that the refund amount has been reflected in the user's application balance at the time of cancellation processing. Cancellation at the store is

- only possible if the amount is less than the unredeemed amount. If you need to cancel more than the amount that has not yet been redeemed, please contact the FUKUOKA NEXT Pay call center as we cannot process it at the store.
- OIf the store independently determines products that are not eligible for the use of gift certificates (bargain items, etc.), please indicate this on display shelves, flyers, etc. so that users can recognize it in advance.
- OIf you decide that the discount cannot be used in conjunction with other discount plans, are not eligible for points, or have a limit on the amount of gift certificates that can be used, please make this clear on display shelves, flyers, etc. so that users can recognize it in advance.
- OThe issuer is not responsible for the theft, loss, loss, forgery, imitation, etc. of gift certificates.

III. Items not eligible for gift certificates

- OConverting to cash, depositing to a financial institution
- OExchange of gift certificates for cash is prohibited.
- OSecurities, cash vouchers, gift certificates (beer coupons, sake coupons, rice coupons, book coupons, gift certificates issued by stores, etc.), travel coupons, train tickets, postage stamps, postcards, stamps, prepaid cards, etc. purchase of things
- OPurchase of manufactured tobacco prescribed in Article 2, Paragraph
- 1, Item 3 of the Tobacco Business Law (Law No. 68 of August 10, 1984)
- OVouchers with lottery prizes (lottery) prescribed in Article 2 of the Voucher Law with Prizes (Law No. 144 of 1948) and Law Concerning the Implementation of Sports Promotion Vote (Law No. Purchasing sports promotion voting tickets as stipulated in Article 2
- OPurchasing ski lift passes, annual passes, golf passes, and other tickets without expiry dates.
- OPurchasing membership fees, exchange tickets for products and services, etc. that are paid in advance, and whose expiration date exceeds December 18, 2023.
- OPayment of investments and debts (taxes, transfer price, transfer fees, insurance premiums, electricity, gas, water, telephone charges, garbage bags designated by Fukuoka City, etc.)
- OPayments related to real estate such as land/house purchases, rent/land rent/parking fees (excluding temporary custody)

- OPurchasing raw materials, equipment, and purchased products used in business activities
- OPayment of co-payments for medical insurance, long-term care insurance, etc. (including medicines requiring a prescription)
- OSex-related special business as stipulated in Article 2 of the Law Concerning Regulation of Adult Entertainment Business, etc. and Optimization of Business (Law No. 122 of 1948), and business that may arouse the gambling spirit of customers by setting up facilities. and payments required for cabarets, clubs, waiting areas, etc. that do not serve meals as the main purpose
- OPayments to those associated with a specific religious or political group or against public order and morals
- Other payments to items specified by each handling store
- OPayment for other items that do not match the purpose of issuing this gift certificate

IV. Eligibility for registration

Those who have offices, stores, etc. in the city and can restrict the use of gift certificates only at stores, etc. in Fukuoka city. However, the following businesses are excluded.

- a. Sex-related special businesses stipulated in Article 2 of the Law Concerning Regulations and Business Optimization of Adult Entertainment Businesses, etc. (Law No. 122 of 1948); and those who operate cabarets, clubs, waiting rooms, etc. whose main purpose is not to provide meals.
- b. A person who is involved in a specific religious or political group, or whose business is contrary to public order and morals.
- c. Transactions listed in 3. [Things not covered by gift certificates] above, stores that handle only products
- d. Persons who are subject to measures to suspend participation in bidding or to be excluded from bidding by Fukuoka City
- e. "Local Autonomy Law Enforcement Order (Cabinet Order No. 16 of 1947)" Article 167-4 Paragraph 2 No. 2 and "Criminal Law (Law No. 45 of 1907)" Article 198 or the Law Concerning Prohibition of Private Monopolization and Maintenance of Fair Trade (Law

- No. 54 of 1947) and Article 3 of the Code of Criminal Procedure (Law No. 131 of 1948) "Persons, etc. who are being prosecuted under the provisions of Article 247
- f. "Local Autonomy Law Enforcement Order (Cabinet Order No. 16 of 1947)" Article 167-4 Paragraph 2 No. 2 and "Criminal Law (Law No. 45 of 1907)" Article 198 or the Law Concerning Prohibition of Private Monopolization and Maintenance of Fair Trade (Law No. 54 of 1947) and Article 3 of the Code of Criminal Procedure (Law No. 131 of 1948) "Persons, etc. who are being prosecuted under the provisions of Article 247
- g. Officers, etc. (Corporate officers including part-time officers, managers, and representatives of branches or business offices; In other organizations, persons with the same responsibility as corporate officers; Individuals, such persons and managers and a representative of a branch office or business office; A member of an organized crime group as defined in Article 2, item 6. The same shall apply hereinafter).
- h. When an organized crime group (meaning an organized crime group stipulated in Item 2, Article 2 of the Anti-Boryokudan Act; the same shall apply hereinafter) or a member of an organized crime group is substantially involved in the management.
- i. When an officer, etc. is using an organized crime group or a member of an organized crime group for the purpose of unfairly benefiting the company, himself or a third party, or inflicting damage on a third party.
- j. When an officer, etc. directly or actively cooperates with or is involved in the maintenance and operation of an organized crime group, such as by providing funds, etc., or convenience to an organized crime group or its members.
- k. When an Officer, etc. has a socially condemned relationship with an organized crime group or a member of an organized crime group.

V. Matters to be observed by registered stores

You must comply with the following matters.

- a. Please post sales tools (posters and stickers) in places where users can easily find them so that it is clear that you are a registered store.
- b. Please make sure that there is no problem with the gift certificate used by the user after making the payment. In addition, if the application specifications are different, etc., and if it can be distinguished as a counterfeit gift certificate, please refuse to receive the gift certificate and promptly report the fact to the police. Also, please report this to the FUKUOKA NEXT Pay Call Center.
- c. Check the merchant confirmation page to ensure that each payment was properly processed.
- d. Only gift certificates used for transactions such as buying and selling products or providing services during the usage period can be redeemed.
- e. Please check if there is any difference in the amount deposited at the time of cash exchange. In the unlikely event that there is a discrepancy, please file an objection within 2 weeks after payment.
- f. Please cooperate with the operation of the electronic gift certificate business with premium.

VI. About registration store application

(1) Application method

①Applicants who wish to register must agree to this "Application Guidelines and Terms of Use", enter or fill in the necessary information in the "Fukuoka City Premium Electronic Gift Certificate FUKUOKA NEXT Pay Registered Store Application Form", and apply by either of the following methods. please.

- ②Businesses with multiple stores in the city, such as large stores, mass retailers, chain stores, affiliated stores, etc., should, in principle, apply for each business, not for each store. (Available at all stores). In this case, it is necessary for all registered stores to agree to the contents of the "recruitment guidelines" and apply. Please apply for registration from the special site.
 - *Please specify the payment account in a lump sum.
- *When specifying for each store, specify a different account. If you have specified the same account for each store, we may change it to a batch designation.
- (2) Application period

First recruitment: From April 10, 2023 (Mon) to May 10, 2023 (Wed)

- * Start date of use as registered store: June 19 (Mon)
- * Store kit will be shipped in early June.

Second recruitment: From May 11, 2023 (Thu) to May 31, 2023 (Wed)

* Start date of use as registered store: July 1(Sat)

Third recruitment: From June 1, 2023 (Thu) to June 15, 2023 (Thu)

* Start date of use as registered store: July 16 (Sun)

4th recruitment: From June 16, 2023 (Fri) to June 30, 2023 (Fri)

* Start date of use as registered store: August 1 (Tue)

5th recruitment: From July 1, 2023 (Sat) to July 15, 2023 (Sat)

* Start date of use as registered store: August 16 (Wed)

6th recruitment: From July 16, 2023 (Sun) to July 31, 2023 (Mon)

* Start date of use as registered store: September 1 (Fri)

7th recruitment : From August 1 2023 (Tue) to August 15 2023 (Tue)

* Start date of use as registered store: September 16 (Sat)

8th recruitment (final one): From August 16 2023 (Wed) to August 31 2023 (Thu)

- * Start date of use as registered store: October 1 (Sun)
- (3) Registration/approval

Businesses that have applied will be approved as registered stores after examination by the issuer. However, even after approval, approval may be revoked in the following cases.

- ①If there is any falsehood or incompleteness in the content of the application
 - ②If the issuer decides to revoke the approval

In addition, we will distribute sales promotion tools such as registered store display stickers for store display at a later date to businesses that have been approved as registered stores.

VII. About redemption

Registered stores that have used gift certificates to settle transactions such as the sale of goods or the provision of services can redeem them for cash according to the following (1) to (3).

- (1) The registered store will specify the account to which the payment will be made when applying for registration. Based on the payment data, the payment will be automatically transferred to the designated account according to the schedule specified in (3).
- (2) Payment will be made to the designated account at the registered store on the scheduled transfer date twice a month, in principle, according to the settlement period.

- *The closing date is the end of the month for the first month only, and the 15th and the end of each month thereafter.
- *The scheduled transfer date and the actual payment date may differ depending on the financial institution you specify.
- *The above schedule is tentative and subject to change. For the final schedule,

please be sure to check the "Registered store manual" that will be distributed at a later date.

VII. Cancellation of registered store, etc.

If an act that violates the "recruitment requirements and terms of use" is recognized, we may refuse to redeem the money or cancel the approval of the registered store. In addition, if damages are incurred due to the violation, we may claim for damages.

IX. Other considerations

- (1) Please refer to the "Registered store manual" in the registration kit for details on how to handle gift certificates and how to redeem them.
- (2) Issuers will decide on a case-by-case basis any matters that are not stated or stipulated in the "Recruitment Requirements and Terms of Use".
- (3) Store information (store name, location, telephone number, type of business, etc.) of registered stores will be publicized on the "FUKUOKA NEXT Pay" website and other methods.
- (4) Prior notification is required for the creation and display of publicity notices, including the use of portraits of "gift certificates" designed for this project.

(5) Please understand in advance that the contents may be changed depending on the issuer's policy.

Supplementary provision

This agreement shall come into effect from April 10, 2023.
