

Regulations on the use of logos, designs, etc.

(Effect)

Article 1. These regulations are to widely disseminate and advertise the gift certificate business by using the logo, design, etc. of "FUKUOKA NEXT Pay" (hereinafter referred to as "gift certificate design") owned by the Fukuoka Chamber of Commerce and Industry. At the same time, for the purpose of deepening the correct understanding of users and further improving business effectiveness, necessary matters concerning the handling of gift certificate designs shall be established.

(Notification of use, etc.)

Article 2 Those who wish to use the gift certificate design must submit a usage notification form (Form No. 1) with the required documents to the Fukuoka Chamber of Commerce and Industry in advance. However, this shall not apply when any of the following items apply.

1. When used by Fukuoka Prefecture, Fukuoka City, Fukuoka Chamber of Commerce and Industry, Sawara Chamber of Commerce and Industry, Shiga Chamber of Commerce and Industry, and some shopping arcade in Fukuoka City that are the issuer.
2. When a Registered Store posts sales tools created by the Publisher.
3. When used by news media for reporting purposes.
4. For personal use or domestic use.

(Permission/non-permission of use)

Article 3 When the Fukuoka Chamber of Commerce and Industry receives the notification of use in the preceding article, in principle, the use shall be permitted, and the permit shall not be issued. However, in the event of disapproval, the Fukuoka Chamber of Commerce and Industry will send an e-mail to that effect.

(Matters to be observed in use)

Article 4 Those who use gift certificate designs must comply with the following items.

1. Correctly use the specified colors, shapes, etc., and do not alter the colors, shapes, fonts, etc.
2. The user shall not transfer or sublease it.
3. The finished product shall be submitted promptly. However, if it is difficult to submit the completed product, the photograph or design may be substituted.
4. Use it according to the notified contents and follow the conditions instructed by the Fukuoka Chamber of Commerce and Industry.

(Usage fee)

Article 5 Usage fee shall be free.

(Period of use)

Article 6 The period during which the gift certificate design can be used is up to February 15, 2023. However, if notification is made, it shall be within the period of use described in the notification of use.

(use restrictions)

Article 7 The Fukuoka Chamber of Commerce and Industry shall restrict the use of gift certificate designs if the content falls under any of the following items.

1. When it damages the dignity of the Fukuoka Chamber of Commerce or interferes with correct understanding.
2. When you do not use the gift certificate design according to the correct usage.
3. When it violates or is likely to violate laws and regulations or public order and morals.
4. When giving, or there is a risk of giving, the misunderstanding that you are supporting or endorsing a specific individual, political party or religious group.
5. In addition, when the Fukuoka Chamber of Commerce and Industry deems the use of the gift certificate design inappropriate.

(Prohibition of Use)

Article 8 The Fukuoka Chamber of Commerce and Industry may suspend the use of the gift certificate design if it is deemed that the use of the gift certificate design violates these regulations and the contents of the notification.

2. Suspension of use as set forth in the preceding paragraph shall be effected by means of a notice of suspension of use.

(Limitation of Liability)

Article 9 If the use of the gift certificate design is prohibited pursuant to the provisions of the preceding article, the Fukuoka Chamber of Commerce and Industry shall not be held responsible for any damage caused to the user.

2. Even if the person who uses the gift certificate design causes damage or loss to a third party through the use of the gift certificate design, the Fukuoka Chamber of Commerce and Industry shall not be liable for damages, loss compensation, or other legal liability. bear nothing.

(Supplementary provision)

Article 10 In addition to what is stipulated in these regulations, the Fukuoka Chamber of Commerce and Industry shall separately stipulate necessary matters concerning the handling of gift certificate designs.

Supplementary provision

1. These regulations shall be enforced from April 10, 2023.
2. The following two points are the design of gift certificates subject to these usage regulations.
